Terms and Conditions

A. HOW TO ENTER

Send up to 3 photos to showcase your costume to JHPhotos@gmail.com by 11:59 PM October 25, 2020. You must include with your photo(s) name(s), age(s) if under 18, a description of the costume(s), and any Journey House programs the person(s) are involved in.

**Photos must be in good taste, legal, accurate and true, non-defamatory, non-threatening, non-confidential, non-infringing of copyrights owned by others.

B. SELECTION OF WINNERS AND JUDGING CRITERIA

All eligible entries will be judged by Journey House participants and the public in 5 categories: "Young Kids 0-5," "Youth 6-12," "Teen 13-17," "Adult 18+," and "Family". The judging criteria to be used will be based on creativity and originality of costume whether it is store bought or home-made. Winners will be announced live online on Saturday, October 31st at 10am on Facebook Live. By participating, entrants agree to these Terms and Conditions and the decisions of the voters and Journey House staff and participants, which shall be final and binding in all respects.

C. ELIGIBILITY

Contest void where prohibited by law. All federal, state, and local laws and regulations apply.

D. CONDITIONS OF PARTICIPATION

Winners will be notified live online as well as by email and must respond within three (3) days of attempted notification or be disqualified.

Submission of an entry constitutes the irrevocable grant to Journey House of all rights in the entry, all rights to publish, use, adapt, edit, and/or modify such entry in any way and in any and all media, without limitation, and without consideration

or acknowledgment to the entrant and the unconditional right to use the photograph and statements about the promotion for advertising/publicity purposes without additional compensation, except where prohibited by law.

E. COSTUME CATEGORIES AND PRIZES

Winners will be selected in 6 categories to receive prizes

Best Young Kid (age 0-5)

Best Youth (age 6-12)

Best Teen costume (age 13-17)

Best Adult costume (age 18+)

Best Family costume

F. GENERAL CONDITIONS
